

Privilege and dominant status may operate in an individual, team or circumstance, yet outside of conscious awareness. Privilege may be taken for granted as the natural way of things. Concepts to be discussed include: unconscious privilege, assumptions, dominant status, internalized oppression,fragility, bias and discrimination.
